



ประกาศโรงเรียนวังม่วงพิทยาคม

เรื่อง เจตจำนงสุจริตในการบริหารงานโรงเรียนวังม่วงพิทยาคม

การป้องกันและปราบปรามการทุจริตและประพฤติมิชอบในภาครัฐ เป็นหนึ่งในนโยบายสำคัญของประเทศที่ระบุไว้ในแผนยุทธศาสตร์ชาติระยะ 20 ปี แผนพัฒนาเศรษฐกิจและสังคมแห่งชาติ ฉบับที่ 12 และแผนยุทธศาสตร์ว่าด้วยการป้องกันและปราบปรามการทุจริต ระยะที่ 3 (พ.ศ. 2560-2564) เพื่อให้หน่วยงานในภาครัฐบริหารงานด้วยคุณธรรมและความโปร่งใสและสนับสนุนการยกระดับดัชนีการรับรู้การทุจริต (CORRUPTION PERCEPTION Index : Cpi) ของประเทศให้อยู่ในระดับที่สูงขึ้นรวมทั้งมติคณะรัฐมนตรี เมื่อวันที่ 5 มกราคม 2560 เห็นชอบให้หน่วยงานภาครัฐทุกหน่วยงานเข้ารับการประเมินคุณธรรมและความโปร่งใสในการดำเนินงานของหน่วยงานภาครัฐในปีพ.ศ. 2559 ถึง 2560 และมติคณะรัฐมนตรีเมื่อวันที่ 23 มกราคม 2561 เห็นชอบให้หน่วยงานภาครัฐทุกหน่วยงานให้ความร่วมมือและเข้าร่วมการประเมินคุณธรรมและความโปร่งใสในการดำเนินงานของหน่วยงานภาครัฐ ในปีงบประมาณพ.ศ. 2561 ถึง 2565 โดยให้หัวหน้าส่วนราชการให้ความสำคัญกับการประเมินคุณธรรมและความโปร่งใสในการดำเนินงานของหน่วยงานภาครัฐ และให้นำผลการประเมินไปปรับปรุงพัฒนาตนเองด้านคุณธรรมและความโปร่งใสอย่างเคร่งครัด

Thailand's National Anti-Corruption Commission is one of the major policies of the country as stated in the 20-year National Strategic Plan, National Economic and Social Development Plan NO. 12 and National Anti-Corruption Strategy, Phase 3 (2017-2020) to let the government agencies work with integrity and transparency and set Thailand's score in corruption perception index to be higher. Also, on January 5, 2017 the Cabinet approved the state government agencies assessed integrity and transparency Assessment in the year 2016-2017 and in January 23, 2018, the Cabinet also agreed that all government agencies must join integrity and Transparency Assessment in fiscal year 2018-2022. The head of a government agencies will focus on assessing the Integrity and Transparency Assessment and improve the moral self-improvement and transparency strictly based on the results of the evaluation.

Wangmuang Pittayakhom School is well aware and focus on the government policies and follow the moral Ethics and Good Governance in Schools "Anti-Corruption" under Educational Service Area Office's Anti-Corruption to propel the National Anti-Corruption Strategy and focus on Cabinet's mission as above into the operation.

Phòng ngừa và ngăn chặn tham nhũng và hành vi sai trái trong khu vực chính phủ Đây là một trong những chính sách quan trọng của đất nước được nêu trong Kế hoạch Chiến lược Quốc gia 20 năm. Kế hoạch Phát triển Kinh tế và Xã hội Quốc gia số 12 và Kế hoạch Chiến lược về Phòng chống Tham nhũng Giai đoạn 3 (2017-2021) nhằm tạo điều kiện cho các cơ quan chính phủ quản lý công việc của họ một cách liêm chính và minh bạch, đồng thời hỗ trợ nâng cao Chỉ số Nhận thức Tham (CORRUPTION PERCEPTION Index : Cpi) những quốc gia lên cấp độ cao hơn, bao gồm cả Nghị quyết Nội các vào ngày 5 tháng 1 năm 2017 đã phê duyệt tất cả các cơ quan chính phủ để đánh giá tính liêm chính và minh bạch trong hoạt động của các cơ quan chính phủ trong năm 2016 đến 2017. Và nghị quyết của Nội các ngày 23 tháng 1 năm 2018, nhất trí rằng tất cả các cơ quan chính phủ hợp tác và tham gia đánh giá tính liêm chính và minh bạch trong hoạt động của các cơ quan chính phủ. Trong năm tài chính từ năm 2018 đến năm 2022 bằng cách cho phép người đứng đầu các cơ quan chính phủ tập trung vào đánh giá đạo đức và tính minh bạch trong hoạt động của các cơ quan chính phủ và áp dụng nghiêm túc kết quả đánh giá để nâng cao đạo đức và tính minh bạch của chính họ.

Trường Wangmuang Pittayakom Có nhận thức và tập trung vào vấn đề này và tham gia vào các dự án nâng cao đạo đức, đạo đức và quản trị tốt trong các cơ sở giáo dục Các hoạt động “Phòng chống tham nhũng” trong Văn phòng Khu vực Giáo dục Tham nhũng nhằm thúc đẩy Chiến lược Quốc gia Phòng chống Tham nhũng của Văn phòng Ủy ban Chống Tham nhũng Quốc gia và thực hiện sứ mệnh theo nghị quyết của Nội các một cách cụ thể và nhất quán.

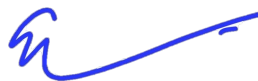
