

Announcement of Wat Kuha Suwan (Wankhru 2504) School

Regarding the policy of giving and receiving gifts at the New Year's Festival

or any other opportunity (No Gift Policy)

According to the Constitutional Act on Preventing and Suppressing Corruption B.E. 2021 section 128 stipulates that no government official shall receive any property or any other benefit. Which may be calculated as Income from anyone other than property or reasonable benefits by the laws, rules, and regulations issued under the provisions of the law Unless the receipt of property or any other benefit is unethical Criteria and number set by the National Anti-Corruption Commission.

Wat Kuha Suwan (Wankhru 2504) School has therefore established a policy to give and receive gifts at New Year's Festival or any other opportunity (No Gift Policy) to strengthen the values, attitudes, consciousness, and behavior of executives, civil servants, teachers, and personnel. Study under not accepting and not tolerating corruption and avoidance of actions that may affect the decision to perform duties which will lead to discrimination or cause conflicts of interest. And is to prevent corruption and misconduct in another way as follows

- Executives, civil servants, teachers, and educational personnel should not demand or receive property gifts or any other benefits from those involved in the performance of duties Which will cause the operation to not meet ethical standards, may affect the decision to perform duties and should study the principles and concepts that use the implementation of gift giving and receiving policies by the rules of the National Anti-Corruption Commission.
- 2. Giving gifts according to tradition, the value of gifts provided must comply with specified laws and regulations as well as should refrain from giving gifts and gifts that affect the decision to perform duties

- 3. If there is a New Year's party Let's go to create love, unity, and encouragement among the faculty. It is with simplicity, not extravagant, and taking into account the best interests of Wat Kuha Suwan (Wankhru 2504) School and the public.
- 4. Supervisors of all levels must behave and maintain a good role model. Along with the supervision of civil servants, teachers, and educational personnel to behave about giving and receiving gifts or other benefits correctly and comply with relevant laws, regulations, or announcements.
- 5. No more solicitation among civil servants, teachers, and educational personnel. Or the use of any other welfare funds of the public to provide gifts to the absolute supervisor.
- 6. Should use a greeting card and sign a greeting book. Congratulations, and greeting cards on social media instead of giving gifts that are worth more than the law. To strengthen the attitude of saving create the thrifty values of civil servants, teachers, and educational personnel of Wat Kuha Suwan (Wankhru 2504) School.
- 7. In the case of receiving gifts or receiving benefits to comply with the rules of the National Anti-Corruption. Commission government officials cannot accept gifts or any other benefits except by ethics only.
- 8. Let civil servants, teachers, and educational personnel at Wat Kuha Suwan (Wankhru 2504) School treat themselves to the New Year's gift and gift collection policy. Or any other opportunity (No Gift Policy) strictly.
