Policy on not accepting gifts from Accepting all kinds of gifts from performing duties

(No Gift Policy)

With the Office of the Basic Education Commission and the Educational Service Area Office Phuket Primary School There is a policy for schools to comply with the Organic Act on Prevention. and suppressing corruption 2018, Section 124, paragraph one, which states that Do not give it to any government official. Receive property or any other benefits that may be From whom is the income calculated In addition to assets or benefits should be in accordance with laws, rules or regulations issued by virtue of power according to the law Except for receiving property or any other benefits By ethics according to the rules and regulations in the amount specified by the NACC and in accordance with Civil Service Code of Ethics, Section 6 (1), which stipulates not to demand or agree to receive or allow others to demand. or agree to accept a gift on behalf of oneself or one's relatives whether before or after holding a position or performing duties, whether or not it is related to the performance of duties or not. unless it is given out of ethics or given according to tradition or given to the general public.

In order to prevent corruption and misconduct of government officials. Officers and personnel Educational aspect of everyone in Koh Siray School Be aware of corruption. It is important that all sectors must cooperate prevent and eliminate them completely. The operations of government agencies are honest and transparent. Manage work efficiently and good governance, which will give the people confidence, faith, and trust the administration including to strengthen the culture and values of honesty. Reduce corruption and spiritual cultivation. We are conscious of being a good person with honest values and a service mind. Therefore, we have a policy of not accepting gifts in every festival (NO GIFT POLICY) to campaign for teachers and educational personnel refrain from receiving gifts from outsiders and visitors and refrain from giving gifts to outsiders and visitors during the festival. To avoid actions that may affect judgment or decision in performing duties, leading to discrimination or causing conflict of interest. Therefore, it has been announced and strictly adhered to. has established a policy for not accepting gifts and all kinds of gifts from performing duties (No Gift Policy) as follows:

- 1. All government teachers and educational personnel Refrain from accepting gifts and things. All kinds of gifts from performing duties from outsiders who contact.
- 2. All government teachers and educational personnel Refrain from giving gifts and things. All kinds of gifts are given to outsiders who contact.
- 3. All government teachers and educational personnel You must not seek to obtain gifts. Gifts or unlawful benefits
- 4. Congratulations expression of good wishes Reception or performance regrets on various occasions according to normal traditions The method of expression should be signed by signing a scrapbook greeting card. greeting condolence card or use social media instead of giving things.
- 5. All government teachers and educational personnel Has a duty to inform outsiders about such policy is comprehensive.
